INVITATION TO BID FOR "Procurement of Motor Vehicle"

The UNESCO National Commission of the Philippines (UNACOM), through the FY 2024 Specific Budget of UNACOM intends to apply the sum of **Two Million Six Hundred Fifty Thousand Pesos only (P2,650,000.00)** being the Approved Budget for the Contract (ABC) to payments under the contract for "**Procurement of Motor Vehicle**" (Project ID No. UNACOM-2024-MV-001)

- Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The UNACOM now invites bids for the above Procurement Project. Delivery of the Goods is required as specified in Section VI (Schedule of Requirements) of the Bidding Documents. Bidders should have completed, within **one hundred eighty (180) days** from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
- 3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
 - a. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.
- Prospective Bidders may obtain further information from UNACOM through the contact details given below and inspect the Bidding Documents at the address given below during office hours from Mondays to Fridays at 8:00 AM to 5:00 PM.
- 5. A complete set of Bidding Documents may be acquired by interested Bidders starting on 11 June 2024 at UNESCO National Commission of the Philippines (UNACOM), Ground Floor Department of Foreign Affairs, 2330 Roxas Boulevard, Pasay City, Philippines 1300, upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Five Thousand Pesos only (Php 5,000.00). The Procuring Entity shall allow the bidder to present its proof of payment for the fees to present in person.
- 6. The UNACOM will hold a Pre-Bid Conference on 24 June 2024 at exactly 1:30 PM (Philippine Standard Time) at UNESCO National Commission of the Philippines (UNACOM), Ground Floor Department of Foreign Affairs, 2330 Roxas Boulevard, Pasay City, Philippines 1300, which shall be open to prospective bidders.
